One of the Company's investments experienced a significant decline in its share price following the release of a preliminary major loss in its half-yearly report, for 2024. The results revealed an unexpected loss ranging from \$13million to \$15million, primarily attributed to lower-than-anticipated sales and a one-off non-cash write-down of inventory which will be subject to audit.

As a result, the fair value of the Company's investment has decreased by a further \$46,000 as of February 2024 (\$77,000 as at 31 December 2023). The shares are been held as the market price fell below adjusted net tangible asset value.

Any other factors which have affected the results in the period, or which are likely to affect results in the future, including those where the effect could not be quantified.

The company suspended exploration activities due to lack of technical skills or financial capabilities however continues to undertake patient investing in established and well managed stocks to provide funds to cover costs until royalty stream interests provide returns.

Due to the payment of tax the company has franking credits amounting to \$3,711,014 available for payment of a dividend. Dividends will be paid when the Board of Directors decide.
